IX. ITEMS FOR DISCUSSION AND/OR ACTION

A. Donna Sierks/General Acrylics/Track Information/Update

Ms. Sierks didn't really have a presentation and said she's mainly here as a resource and will answer any questions the board has regarding

the track. She has pictures of the track if anyone who hasn't walked it would like to view.

The track has a lot of problems and she wouldn't have anyone running on it currently for safety reasons; especially on the back straight away.

The first solution and the absolute minimum to make it safe to use, would be to remove and patch some of the areas. Eventually those patches will open up again. You never know exactly how long the patches will hold up; maybe that night or maybe in 3 years. To repair/patch would cost a substantial amount running about \$49,130. Patching does work but eventually causes the areas next to the patch to start cracking. We may have use of the track for one year after the patchwork.

The second option was to take the surface off and resurface. There are a whole lot of "and's" if's" or "buts" about that because literally the problem is underneath the surface and you can't fix the top with the bottom that's bad. The waves in the track are what's caused by the under surface. This is a major issue. Price on that is \$184,950. This amount includes the removal the disposal and everything. (Will give you about 5 years use but will have some work to do during that timeframe.) That amount is based on whether the heavy equipment can hold without falling through.

Third: Ideal one is to go in remove surface and remove the asphalt and see what we find. The proposal she put together was for the removal, disposal and re-compacting base and adding 2 inches of ABC. If we need one ton less we would get credited back, or if they have to use more, it would cost us more. We would bring in a paver that paves a running track. This also includes resurfacing the high jump area.

Superintendent Heap said the drains have to be moved if we do this. He asked if the removal of the drains is included in their price.

Ms. Sierks said moving it won't be a problem. The biggest problem is reconfiguration. She feels we could redirect the drains where they are.

That cost is \$378,774, lasting anywhere from 20 to 25 years. It's definitely not inexpensive but asphalt is not inexpensive. This would be totally rebuilding. She thinks to use concrete it could cost about \$100,000 to \$150,000 more than asphalt. The upgrade in surface tops is about a \$38,000 difference.

President Zieler said we weren't looking to find ways to spend money it was just something we discovered during a facilities walk through this year.

Mr. Overson had three questions. One - liability. How bad are we right now with kids practicing on it every day, according to your experience?

Ms. Sierks – your liability is in a couple of areas where you can pick up some track that's not attached because the surface moves. The cracks aren't as big of a deal.

Mr. Overson - Two - Has she ever caught wind of how school districts pay for it or where they get the money to pay for it. Are there any tricks?

Ms. Sierks - She wishes she knew. She's been researching it. Most just bite the bullet and find the money somewhere.

Mr. Overson – Three - The idea has come up a couple of times, how much to put turf in?

Ms. Sierks – To completely rebuild and put turf in is around \$800,000 to 1 million dollars. Turf is warrantied for 8 years. Between 10 and 12 years you have to begin replace it which will be \$200,000 to \$250,000.

Mr. Wiltbank asked how long it takes to complete.

Ms. Sierks said we do most in the time frame from 7th of June to 15th of August. Surface has to be put in at 45 degrees weather or better. Start to finish is about 6 weeks.

Concrete has to cure for a month, asphalt for 2 weeks. When you just resurface it takes just 3 to 4 weeks.

She appreciates talking directly to you. Call her if you have questions at any time.

Mr. Overson said he was confused because he thought we were going to patch a little bit of it.

President Zieler said wasn't. He thought it was clear that we weren't thinking of that because we didn't want to throw money away.

The board would like to discuss this item further in the next board meeting.

Superintendent Heap brought everyone up to date on this addendum. We use therapists through this consortium so we don't have to have our own therapists. During a recent Administration meeting we discussed that our population of students are going down but our population of special needs students going up. Concerns us somewhat and working with the consortium is something we have to do.

Superintendent Heap recommended approval but noted that we will stay within our bounds as best we can.

I. Signing-Loyalty Bonus/District Insurance Cost Increase Superintendent Heap said as you are aware insurance is going up just about everywhere. This insurance is going up 7.69%.

We will be down some students this year which is the main source of our funding. We are getting an increase of 4.1% from the state and it's for one year only. We were advised not to tie that increase to teacher's salaries, or anything due to being a one year increase only. When you give a raise you have to sustain that increase every year. We gave a bonus for one time last year using our insurance premium money. We wish we could give an increase every year but we are now the lowest compensated state in the US.

The administrators met again this Monday to discuss this item further. Mr. Boyle came up with a recommendation and we discussed as an administrative group to give a 3% bonus amount to our staff. Last year we gave a flat rate, onetime bonus. With the insurance increase of 7.69% we also decided that the district pick up 4% of that increase and carry that or sustain that from now on. We will have to budget wisely for that but it should help the employees more than the monetary

amount because they get taxed on that and not with the insurance. The employees then would only have a 3.69% increase. About a \$50 increase per month for those on the A family plan. We will have to use money out of our pre-pay and we understand it's going to continue to go down.

Mr. Overson asked where the prepay amount stands.

Mr. Boyle - 1.2 million. Which will grow to 1.4 million this year.

Mr. Boyle said we have money in our 550 of \$20,000 which we plan to use all or a portion of that towards the \$33,000 and work in the budget cuts to sustain us.

Superintendent Heap - We did not get a percentage cut from insurance this year. They usually give us a little deduction due to the district prepaying our insurance but this year they would not budge.

Mr. Boyle – We've worked really hard to educate staff that their use of insurance is what increases the costs every year. It's hard to tell our employees, when they are paying \$700 per month for insurance that they can't go to the doctor because that's what increases their rates.

Mrs. Patterson – If they aren't giving us a break this year then why are we prepaying?

Superintendent Heap said it's the only place we can save money where the state won't take it.

Mrs. Patterson thought that was why but just wanted to be sure.

President Zieler's concern with this recommendation is the staff will only get \$40 dollars more of an increase if we are looking at a teacher making about \$36,000. It concerns him that we don't give the increase to the base while the rest of the world continues to move up.

Superintendent Heap said in 2012 we gave a sizable raise but we didn't raise the base. Remember we have higher addendums than most of the surrounding areas. When we raise the base it also affects the addendums. We would love to offer more but we feel with circumstances at this point in time, our recommendation is very reasonable. We have gone over this a lot.

Mr. Boyle – Mr. Essig's recommendation is that we should not count on sustainable money until next year at this time when we might know more.

We also are not tying ourselves to ASBAIT. We are continuing to shop around.

Mr. Burgoyne – raising the base at this point in time, wouldn't be wise.

Mr. Hollembeak - To put the increase to the base wouldn't be more than the \$1200 they got last year or the \$1100 or so they will get this year.

Mr. Boyle said the bonus last year and this year figures out to be 6% increase. Holbrook has been giving a 3% increase every year. They are getting an increase even though it's not sustainable every year.

President Zieler said that Superintendent Heap mentioned earlier that if we raise the teacher's base that ties to the addendums and we are at the higher level around the mountain. We need to keep that in mind.

Mr. Overson said the administrators have given this a lot of time and thought and he is comfortable with their recommendation and feels we can move along.

Mr. Burgoyne had one more suggestion. He worries about doing the percent that there will be some backlash towards administrators. We talked about putting a cap to highest paid teachers or administrators.

Mr. Overson would like to figure out that cap percentage tonight.

Mrs. Patterson said \$2,000 would be the cap for a highest paid teacher. Give a 4% bonus for everybody with a cap at \$2,000 which is the highest paid teacher amount.

Mr. Overson – It's not as much about the savings as the perception. Mr. Overson also thinks it would be wise to get the word out quick.

Mr. Wiltbank suggested just make the motion that we give a one-time bonus of 4% and cap it at the highest paid teacher amount; or not to exceed the highest paid teacher amount.

All agreed on the district carrying 4% of the insurance increase and sustain that amount and to also give a onetime bonus of 4% of their salary. We will spend about \$10,000 more this year than we did last year

Motion/Second to approve a one-time bonus of 4% as discussed, to be capped at the highest paid teacher salary. We also approve 4% of the insurance increase to be picked up and sustained by the district with the remaining 3.69% to be paid by the employee.
