## F. District Purchases and Support of Local Businesses

Superintendent Heap referred to the backup material. This item started with Mr. Heap visiting with him. We discussed the conversation from our last meeting where the student council mentioned not being able to get more local support from local businesses. Mr. Heap visited with Mr. Wiltbank and it brought forth this discussion. Superintendent Heap feels the school district needs to be more supportive with our local businesses. It has to be a conscious mind-set for us. We need to start thinking locally. If we don't start buying locally, we may lose them. He also visited with Mrs. Hauser about buying more locally. He talked to Mr. Connolly about using some of our local mechanics to work on our school vehicles, etc.

Recently Alco decided on their own, that for two days they would donate 2% of all their proceeds to St. Johns Unified School District. Last year they donated a lot of supplies to us. We need to shop locally in any way we can. We would like the school district to take lead in that.

Mr. Heap said this item has been on his mind and feels we should feel obligated to support our businesses which have always helped and supported our students. He visited with the Student Council kids about shopping locally. The Student Council President, Hannah Platt told him today that for their Christmas service project, they shopped locally and bought everything they needed except for basketball shoes that they could not get locally. So they are very well aware and have this on their minds. We are actively pursuing this. Also if we plan ahead, our businesses can order just about anything we need and can also be competitive with their prices. He feels it will foster a better feeling within the community. Mr. Heap wrote quite a bit about this in his report.

Superintendent Heap walked through the hardware store this afternoon. He is really impressed. Well stocked, clean, etc. He also feels we should each start talking more positive about these businesses and see the good in what we have.

Mr. Wiltbank asked if we could put something on the marquee about shopping local.

Superintendent Heap asked if anyone sees a problem with that.

The board did not have a problem with doing that.

Superintendent Heap asked Mrs. Sparks to put on the marquee, SJUSD encourages all to shop locally.

Mr. Overson asked why this item was on the agenda. To make a policy on it?

Superintendent Heap said he just wanted to have direction from the board to encourage our staff, our students and all to look and conscientiously shop locally. He already encouraged Mr. Connolly to talk with our local mechanic shops and he also encouraged Mrs. Hauser to look at buying more food products locally.

Mr. Wiltbank feels we would be surprised how competitive our local businesses are with their prices.

President Zieler said the board gives the administrators direction to make a concerted effort to shop locally.

Mr. Overson mentioned the need for policy.

Mr. Wiltbank doesn't feel it needs to be a policy just a concerted effort.

President Zieler feels we should have some sort of resolution saying our administration can go ahead and shop locally with a caution to watch pricing. That would be one way we could do it. (As long as we didn't go over a certain amount of money.)

Mr. Overson – our policy is to make a conservative effort to shop locally rather than going outside.

Mr. Wiltbank thinks if they just start doing it, it will be a habit, no need to add to a policy.

Superintendent Heap said right now it seems we just need a habit change. Doesn't feel we need a policy for it. It's just an attitude, behavioral change.

President Zieler feels he would like more of a policy.

Mr. Burgoyne says if we make policy we have to go through legal attorneys, have 1<sup>st</sup> and 2<sup>nd</sup> readings, long process. Rather maybe a letter of direction from the school board would be sufficient.

Superintendent Heap feels that to be a good idea and he would be willing to draft a letter for the board.

Mr. Overson feels that would be good because it's kind of more formal.

Mr. Heap plans on doing that for his staff at his school level. We can do that as well at the district level.

President Zieler, maybe put in the newspaper for good local advertisement.

President Zieler – the board would like to direct the administration to draft a letter for the board and bring back to the next board meeting for an official vote.

Mr. Overson appreciates them bringing this up.

## G. High School Track Update

Superintendent Heap - As part of our administration meeting we went out and walked the track. Our recommendation to you is to continue to practice on track and not schedule any meets from either school. Contact vendor to repair asphalt and put a new surface on (\$25,000). We will go ahead and move on this and continue our track practices, etc.

Mr. Overson asked if we were looking at repairs happening this summer.

Superintendent Heap said we would like to look at doing it sooner. If we do it at a certain time of year, they offer a discount.
